- Count 1: Sec. 3-5 (d) (2) Cruelty Care and Maintenance.*
- Count 2: Sec. 3-71 License Required Times Fourteen*
- Count 3: Sec. 3-51 Vaccinations Times Fourteen*
- Count 4: Sec. 3-8.1 Multi-Animal Site Permit and Kennel Permit*

The undersigned, *under penalty of perjury*, complains and says that on or about the September 06, 2022, in the City of Truth or Consequences, State of New Mexico, the above-named defendant(s) did:

Facts:

On Tuesday, September 06, 2022, at approximately 1252 hours I, Animal Control Officer Di Giacomo and Animal Control Officer Knull was on shift wearing a Truth or Consequences Animal Control uniform and driving a marked Truth or Consequences Animal Control unit in the City of Truth or Consequence, County of Sierra, and State of New Mexico, was dispatched to two dogs running at large at 3500 E 3rd Street, Windmill Boat Storage.

When I arrived on scene, Officer Knull and myself drove through the Windmill Boat Storage looking for the two dogs at large. We did not find the two dogs running at large. As Officer Knull and myself were on scene, we noticed over twelve dogs in kennels and two or three running loose in the pen area. I got out of my unit to see what was going on with all these dogs. The two tan in color dogs that were loose in the pen were very thin with ribs showing, spine showing and hip bones showing. One tan dog had a cut on its neck with blood around the wound. It appeared a majority of these dogs were thin. As I continued to look around, the water the dogs had in their private kennels were green and dirty. One container of water was so green it had turned to a soft green slim texture; consistent with algae.

I then went to 3710 East 3rd Street to see if the dogs belong to this address. A female subject came out later identified as Amanda Forrister. I asked Ms. Forrister who did the dogs belong to and she stated her and her husband. I advised Ms. Forrister that I would be issuing a citation for cruelty of animals due to the tan in color thin dogs and the condition of the dogs' water. Ms. Forrister stated "fine". I advised Ms. Forrister I would need to go to my truck to get my ticket book. As I was in my unit, Ms. Forrister arrived at my unit and I asked her what was her last name and she stated Forrister. I then asked her for her first name and she stated Lane. I stated "oh, your name is Lane" and Ms. Forrister stated no that is my husband's name. When I was writing out the ticket, Ms. Forrister gave me the name of Lane Forrister which is her husband to receive the citation.

On Wednesday September 07, 2022, at approximately 1330 hours, Officer Knull, Chief Rodriguez and myself went to speak with Mr. Forrister and Mrs. Forrister about the condition of the animals at 3710 East 3rd Street. After having a conversation with Mr. and Mrs. Forrister, I thought there was a possible solution at this time, however I am not comfortable with solution that was talked about at that time.

I am filing with courts a criminal complaint as follows. Sec. 3-5. (d) (2) Cruelty Care and Maintenance. Sec. 3-8.1. Multi-Animal Site Permit and Kennel Permit. Sec. 3-51 Vaccinations Times 14. Sec. 3-71 License required Times 14

Officer Knull wrote a citation for harboring of animals to Lane Forrister, then later voided the citation.

My citation number 06894 will be voided as well. A criminal complaint will be filed with the courts instead of the citations.

I have nothing further to report at this time.

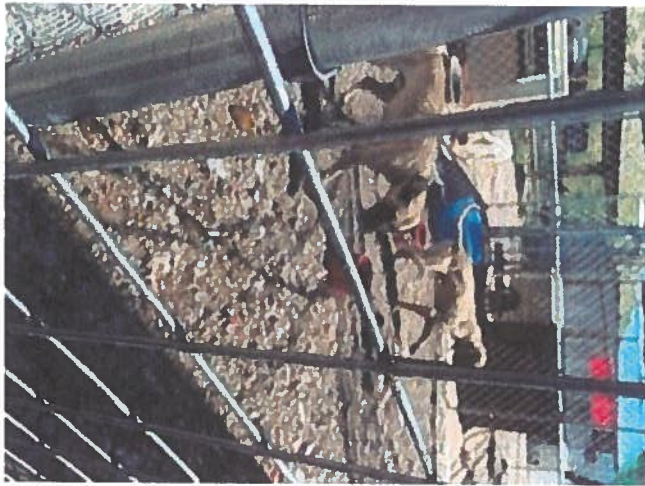
